**EXPRESSION OF INTEREST FOR EMPANELMENT/ENGAGEMENT OF SUPER SPECIALIST
ON CASE TO CASE BASIS UNDER CGHS RATES**

ESIC Medical College & Hospital, K.K. Nagar, Chennai is providing Health Care Services to Insured Persons and their family members covered under ESI scheme. The institution proposes to empanel and engage Super Specialists on case to case basis under CGHS rates as per the terms and conditions given below.

1. Expression of interest is invited for empanelment of Super Specialists in the following departments.
 - i) Medical Oncology
 - ii) Surgical Oncology
 - iii) Plastic Surgery / Burns
 - iv) Nephrology / Hemodialysis
 - v) Urology
 - vi) Cardiology
 - vii) Reproductive medicine
 - viii) Neurology
 - ix) Medical Gastroenterology
 - x) Surgical Gastroenterology
 - xi) Endocrinology & Diabetology
 - xii) Paediatric Surgery
 - xiii) Rheumatology
 - xiv) Neuro Surgery
 - xv) Vascular Surgery
 - xvi) Cardio Vascular Surgery
 - xvii) Hematology
 - xviii) Interventional Radiology
 - xix) Radiologist
2. Interested Super specialists satisfying the eligibility criteria can apply for empanelment in the Application Form annexed herewith.

ELIGIBILITY CRITERIA FOR EMPANELMENT as SUPER SPECIALIST

Upper age limit will be 65 years as on the date of empanelment.

- i) MBBS and MD/MS/DNB Degree from MCI/NMC recognized Medical College/ Institution.
- ii) DM/MCH in respective Super Specialty from MCI/NMC recognized Medical College/DNB in concerned super specialty or equivalent.
- iii) Should have registered with NMC or State Medical Council.
- iv) Two years' experience after completing Super Specialty Degree

Note :

- Eligibility criteria with regard to experience is relaxable at the discretion of the Appointing Authority in case of candidates otherwise well qualified.

Emoluments for the Super Specialist

1. Remuneration will be paid in proportionate to the CGHS Rates as per the table below:

2. Procedures are to be done in-house at ESIC Medical & Hospital, K.K. Nagar, Chennai as per requirements. Supporting manpower and materials will be provided by ESIC.
3. CGHS CHENNAI RATE LIST 2024 – updated w.e.f. 05.02.2024 will be applicable for the empaneled Super specialists.
4. The institution will empanel Super specialists as many as possible and actual allotment of work(engagement) will be done as per the Case load and requirements.
5. Consultation and Procedure timings will be fixed as per the requirements and as far possible in a manner convenient to the Super specialists.

Terms & Conditions of Empanelment/Engagement

- a) In case of selection for empanelment, the engagement of Super Specialist will be to the age of 67 years or the contracted period whichever is earlier.
- b) The Super Specialist shall be available on call 24x7.
- c) The Super Specialist shall be responsible for all cases undergoing treatment under his supervision in that specialty discipline.

- d) **The Selected Super Specialist must have a professional indemnity policy which should cover the period of contractual engagement exclusively for ESIC Medical College & Hospital, KK Nagar, Chennai. The policy is meant to cover professional liability falling on them as a result of error and omissions committed by them while rendering professional services. The minimum sum assured per annum should be Rs.30 lakh for all Super Specialties. A copy of the Insurance and receipt must be submitted at the time of commencement of engagement.**
- e) Selected candidates will have no claim for regularization of services in the Hospital/Medical Institution.
- f) The engagement is subject to Medical Fitness.
- g) Selected Super Specialist will be required to submit acceptance/consent letter in writing before appearing for Medical examination.
- h) The appointing authority reserves the right to terminate the empanelment any time before the tenure without assigning any reason by giving one-month notice. Similarly, the engaged Super specialist will have to give one-month prior notice to discontinue the Empanelment/engagement otherwise they will have to pay an amount equivalent to last one month's remuneration drawn by them in lieu of the notice period.
- i) The selected Super Specialist has to wear his/her own white coat with name badge during the duty hours.
- j) The Super Specialist will be required to mark attendance manually as well as AEBAS (Aadhar Enabled Bio Metric Attendance System).
- k) Candidates are requested to bring their original certificate in evidence of age of proof (date of birth), educational qualification, medical council registration of the State/MCI/NMC, experience certificate along with one set of self - attested photocopies with two recent passport size photographs at the time of Medical Examination.
- l) The remuneration will be paid through the Bank Account of the Super Specialist after deducting the TDS on account of Income Tax and GST as applicable.
- m) The empanelment and engagement will be subject to all the relevant and applicable Legal Provisions.
- n) The selected candidates shall have to submit an agreement incorporating the terms and conditions of engagement on Rs. 100/- stamp paper in the format provided by the Institution.
- o) No kind of malpractices will be allowed, if found empanelment is liable to be terminated without prior notice and disciplinary action may be initiated against them in Medical Council / Appropriate Authorities.

(ii) Mode of Payment:-

A Demand Draft for Rs.500/- (as applicable) in favour of 'ESI Fund Account No.1' drawn on any scheduled bank payable at Chennai has to be submitted along with application form at the time of submitting the application for empanelment.

Note:

- (i) Fee once paid will not be refunded under any circumstances.
- (ii) Only Demand Draft drawn on any Scheduled Bank will be accepted. Application fee Paid by any other mode will not be accepted.
- (iii) The Demand Draft must be issued after the date of issue of this advertisement.

The following testimonials should be submitted at the time Applying for Empanelment:

Selection Procedure:

- (i) The applications received with the requisite fee will be scrutinized by the scrutiny committee of the Institute and the eligible candidates will be called for personal interview before the Selection Committee of the Institute. In case, the number of applicants are large, the selection committee of the Institute may devise criteria for short-listing of the candidates.
- (ii) Only the eligible candidates/ provisionally eligible shortlisted candidates will be called for verification of original documents before the interview. However, the eligibility would be provisional subject to fulfilment of all requirements failing which he/she will not be allowed to appear for the personal interview.
- (iii) The date and time for interview will be intimated to the eligible/ provisionally eligible shortlisted candidates only and the same will also be published in the ESIC website. The information regarding eligibility of candidates will be published in ESIC website only (www.esic.gov.in/recruitments)
- (iv) The selection for empanelment will be made on the basis of performance of the candidate in interview before the Selection Committee.
- (v) Result will be published on the website (www.esic.gov.in/recruitments).
- (vi) Empaneled Super Specialists will be assigned work (engagement) as per the Requirements of the Institutions. Mere empanelment will not bestow any right to claim for engagement.
- (vii) **The Empanelment will be valid for a period of three years. if not cancelled earlier by ESIC.**

General Instructions:

- (i) Mere submission of application does not confer any right to the candidate for empanelment.
- (ii) Application should be submitted in the prescribed format only (Annexure 'A'). The applications submitted in any other format OR incomplete applications will be summarily rejected.
- (iii) ESIC reserves the right to cancel the empanelment/ engagement process at any stage at its discretion and such decision will be binding on all concerned.
- (iv) Wrong declarations/submission of false information or any other action contrary to law shall lead to cancellation at any stage in addition to suitable legal action.
- (v) Empanelment will be purely on provisional basis. Engagement will be subject to detailed scrutiny of eligibility conditions/production of prescribed certificates and other suitable parameters as decided in the best interest of the ESIC Beneficiaries.
- (vi) ESIC will have a right to verify the character and antecedent of the candidate with the concerned Government Authority.
- (vii) All the candidate selected for empanelment will have to submit Police verification certificate at the time of empanelment.
