- Candidates who have already worked as a Senior Resident under Central Residency Scheme for 3 years are not eligible for applying for the post of Senior Resident.
- Candidates working in any Govt. Institution should apply through proper channel. The total period of Residency should not exceed the maximum period of 03 Years.
- Vacancy position in respect of above mentioned seats may increase or decrease at the discretion of the Medical Superintendent.
- **Qualification/Eligibility for SR 3 Years under Central Residency Scheme:** Post Graduate Degree or Diploma in concerned speciality from recognized university, registered with Delhi Medical Council or Medical Council of India are eligible for the post of Senior Resident under Central Residency Scheme.

- **Age:** Not exceeding 45 years as on date of interview (relaxation for SC/ST/OBC as per central government rules).
- OBC Certificate should be in the prescribed format as per Govt. Of India instructions which should certify that the candidate does not belong to any one of the creamy layers.
- **Emoluments for SR 3 Years under Central Residency Scheme:** Rs. 67,700/- as per level-11 of the 7<sup>th</sup> CPC matrix + other allowances per month as per rules applicable. - Interested candidates may appear for interview with self-attested photocopies of Matriculation certificate for proof of age, Caste Certificate, MBBS passing certificate, PG Degree/Diploma passing certificate, valid DMC/MCI/State Registration Certificate & Experience Certificate and proof of residence along with originals for document verification. Candidates should also bring two recent passport size photographs.

**Fee:**

- For General & OBC Candidates fee is Rs. 300/- and for SC/ST is Rs. 75/- in the form of Demand Draft payable at 'New Delhi' in favour of 'ESIC Fund Account No. 1'.
- There is no fee for women & PWD Candidates.

**Terms & Conditions: -**

- Private practice of any kind will not be allowed. (Not applicable for Part-Time Super Specialists)
- No TA/DA will be paid to candidates for appearing in the walk-in-interview.
- Reservation for PWD candidates is as per rule.
- The Medical Superintendent reserves the right to alter the date or cancel the interview without assigning any reason thereof.
- Hostel accommodation/quarters will not be provided.
- Vacancies may change depending upon actual requirement at the time of interview as per discretion of Medical Superintendent.
- On engagement the selected candidate shall be required to deposit an amount of Rs. 30,000/- (Rupees thirty thousand only) through demand draft/banker's cheque payable at New Delhi in favour of 'ESIC Fund account no. 1' at the time of joining, which shall be refundable after completion of tenure (minimum six months' service including notice period {30 days}) and production of "No Dues Certificate".
- At the time of joining selected candidates will have to sign an "Agreement" as per ESIC norms on non-judiciary stamp paper of Rs. 100/-. The original contract will be with the hospital and its copy will be with candidate. Cost of the stamp paper will be borne by the candidate.
- At the time of joining selected Specialists must have a professional Indemnity Bond (of at least Rs. 20,00,000/-; i.e., Rupees twenty lakhs only) which should cover the



period as desired by ESIC in the "Agreement". The Bond is meant to cover professional liability falling on them as a result of error and omissions committed by them while rendering professional services. A copy of the insurance and premium and receipt must be submitted within 07 (seven days) from the date of engagement.
